S708 CLEANSING STATEMENT

Ardiden Limited (ASX: ADV – the “Company” or “Ardiden”) confirms pursuant to the Company announcement on 23 March 2016 about the successful Placement, Ardiden has now issued and allotted 48,076,923, ordinary shares as part of a placement to sophisticated investors to raise \$1,250,000 before costs. Below is the applicable Cleansing Notice.

Secondary Trading Exemption:

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under Section 708 or 708A. By the Company giving this notice, a sale of the Securities noted above will fall within the exemption in section 708A(5) of the Act.

 - (1) The assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
 - (2) The rights and liabilities attaching to the Securities.
