## CLEANSING STATEMENT

---

**Ardiden Limited** (ASX: ADV – the “Company” or “Ardiden”) has issued and allotted 10,000,000 ordinary shares under Listing Rule 7.1 to the vendor of the New Patricia Gold Prospect, Exiro Minerals Corp. This allotment is part of the consideration for the New Patricia Gold Prospect, under the terms of the agreement announced by the Company on 6 January 2020, to acquire 100% of the New Patricia Gold Prospect. Below is the applicable Cleansing Notice.

### **Secondary Trading Exemption:**

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under Section 708 or 708A. By the Company giving this notice, a sale of the Securities noted above will fall within the exemption in section 708A(5) of the Act.
