First Anniversary Payment at New Patricia and Cleansing Statement

Ardiden Limited (ABN 82 110 884 252) (ASX: ADV) (**Company**) advises that it has issued 12,500,000 fully paid ordinary shares and paid C\$50,000 to Exiro Minerals Corp. (**Exiro**) in respect of the first anniversary payment of the earn-in agreement previously announced on 6 January 2020 over the New Patricia Gold Prospect. The shares were issued utilising Ardiden's Listing Rule 7.1 Placement Capacity.
