Director Placement Completed and Cleansing Statement

Ardiden Limited (ASX: ADV) (**Company**) advises that it has received proceeds of \$100,009 from Directors and has completed the placement of 7,693,000 fully paid ordinary shares (**Shares**) at an issue price of \$0.013 each, to certain Directors as approved at the General Meeting on 14 April 2022.
